## DECISION ON IMPLEMENTATION OF THE PREVIOUS DECISIONS OF THE EXECUTIVE COUNCIL AND THE ASSEMBLY OF THE AFRICAN UNION Doc. EX.CL/929(XXVIII)

- 1. **TAKES NOTE** of the Report on Implementation of the Previous Decisions of the Executive Council and the Assembly of the African Union and **ENDORSES** the recommendations contained therein
- **2. REQUESTS** the Commission in collaboration with the Permanent Representatives' Committee (PRC) to:
  - (i) **ENSURE** rationalization of the number of meetings held per year;
  - (ii) **ENSURE** that decisions proposed by the Commission do not exceed three (3) per Department and ensure full implementation within the reporting period before another decision is taken on the same subject matter;
  - (iii) ALSO ENSURE that the agenda of the Summit and decisions are rationalized to address strategic rather than administrative issues;
  - (iv) FURTHER ENSURE that adequate financial resources are allocated to enable the Commission effectively implement the decisions of the policy organs;
  - (v) PUT IN PLACE necessary measures to strengthen and ensure effective use of monitoring and evaluation mechanisms for the implementation of policy organs decisions through the improvement of the follow-up matrix;
  - (vi) ENSURE that decisions adopted are reported on once a year to provide for adequate time for implementation by both the Commission and Member States of same and that decisions taken in January be reported on at the next January Summits and the June/July decisions at the June/July Summits;
  - (vii) **ENSURE** that adequate resources are allocated to the Commission to speed up recruitment of qualified personnel;
  - (viii) ALSO ENSURE that decisions on which no action is taken after two (2) or three (3) years are recommended to the policy organs for cancellation;
  - **(ix) BEGIN** the review of the process of adoption of Protocols/Treaties to ensure speedy ratification by Member States;

(x) ENSURE that implementation of decisions that require funding by partners be limited and Member States to make their contributions to the Organisation in time to allow for implementation of decisions.

## DECISION ON THE REPORTS OF THE PRC SUBCOMMITTEES Doc. PRC Report

#### The Executive Council,

**1. TAKES NOTE** of the Report of the Permanent Representatives' Committee (PRC) and **ENDORSES** the recommendations contained therein;

## A. ON ADMINISTRATIVE AND BUDGETARY MATTERS FOR THE 2015 SUPPLEMENTARY BUDGET

- **2. DECIDES** the following:
  - i) The proposed supplementary budget will amount to USD 53,836,582.87 broken down as follows:
    - a) Operating budget of US\$ 1,035,250.39;
    - b) Programme budget: USD 52,801,332.48 to be financed as follows:
      - ➤ Contribution by Member States: :USD 1,324,752.39 subject to availability of funds;
      - ➤ Contributions by Partners: US\$ 52,511,830.48.
  - ii) With effect from the 2017 budget, all budgetary requests should be realistic, detailed and annotated, including the amounts pledged by Partners;
  - iii) Proposals for supplementary budget should be restricted to unforeseen and exceptional circumstances;
  - iv) A supplementary budget of US\$ 150,000.00 should be secured from the Turkish Government as per the latter's pledge in 2015. This should be done before March 2017, failing which such pledge will be lost;
  - v) A supplementary budget of US\$ 1,500,000.00 to be financed from the grant by the Government of the Republic of Congo;
  - vi) A supplementary budget of US\$ 154.000.00 for payment of short term Commission Staff which were recruited for service delivery improvement and whose salaries were to be paid from a partner fund that was not released;
  - vii) The salaries of the said staff members should be provided for in the 2016 budget and paid up to the end of their contracts. However, the job

- descriptions of the said staff should be made available to the next meeting of the PRC;
- viii) The initial approved budget for 2015 is \$393,039.455.00. The total amount for supplementary budget is \$53,836,582.87 which brings the total approved budget for 2015 at \$466,874.038.00;
- ix) The Commission should ensure the observance of competence as well as gender and regional representation in conducting recruitment.
- 3. ALSO TAKES NOTE with concern of the low level of budget execution by the Commission during the period under review and REQUESTS the latter in collaboration with Member States and other Stakeholders to take the necessary measures with a view to enhancing the budget execution rate;
- **4. APPEALS** to all Member States to meet their obligations and clear their arrears as well as their assessed contributions for 2015:
- **5. REQUESTS** the Commission to take up its responsibility of engaging Member States on the need for the latter to honour their obligations;
- **ENCOURAGES** the Commission to pursue dialogue with Partners with a view to bringing them to release their pledged funds for 2015;
- 7. **DECIDES** that the request for supplementary budget from the Administrative Tribunal should be declined since the latter will not be able to hold a Session before the end of the 2015 financial year. However, **REQUESTS** the PRC to consider a top up amount during the 2016 supplementary budget in view of the importance of the Tribunal;
- **8. ALSO REQUESTS** the Commission and the PRC to ensure that there is effective communication to enhance information sharing:
- **9. FURTHER REQUESTS** the Commission to report on the implementation of this decision in January 2017.

#### B. ON PROGRAMMES AND CONFERENCES

- **10. REQUESTS** the Commission to highlight the budgetary assumptions on how the programmes and activities around the 2017 theme of the African Union would impact and shape the budget;
- **11. EMPHASIZES** the need for Member States to increase their contributions to the programme budget as well as the peace operations budget;

- **12. ALSO REQUESTS** the Commission to ensure that Budget Framework Paper (BFP) takes into account the priorities identified in Agenda 2063;
- **13. FURTHER REQUESTS** the Commission to factor the operationalization of the African Standby Force (ASF) and its budget implications into the BFP.

#### C. ON STRUCTURAL REFORMS

- **14. TAKES NOTE** of the Report of the Permanent Representatives' Committee(PRC) on the on-going Structural Reforms of the African Union Organs in particular the Commission pursuant to Executive Council Decision EX.CL/Dec. 877 (XXVII) adopted in Johannesburg, South Africa in June 2015;
- **15. REQUESTS** the Commission, working in collaboration with the PRC, to finalize all the proposals with a view to submit a final report at the next Ordinary Session of the Executive Council scheduled for July 2016;
- **16. FURTHER REQUESTS** the Commission to:
  - a) present a status report to the PRC on a regular basis and draw up timelines on the implementation plan;
  - b) Strictly apply the provisions of the existing African Union Staff Regulations and Rules regarding compulsory retirement of both regular and short term staff as well as implement an effective succession planning system;
  - c) Ensure that the financial implication of the proposed structure is not more than the already anticipated additional cost of USD 1.5 million to Member States and the additional staff strength should be covered using the savings that will be generated through improving processes and cost efficiencies mechanism as well as eliminating wastes;
  - d) Reduce its operational dependence on partners' funds in the management of key and sensitive posts in the proposed structure;
  - e) Present a detailed report on the financial implication of the proposed structure in the light of the identified posts and job descriptions;
  - f) Design and submit the macro structure for Peace Keeping Liaison Offices for inclusion into the structure of the Department of Peace and Security;
  - i) To implement the measures to improve operational efficiency and effectiveness that do not entail structural reform.

#### D. ON AUDIT MATTERS

17. **REQUESTS** the Commission to continue to follow-up on the implementation of the recommendations of the Office of Internal Audit as well as those of the Board of External Auditors and report on Audit Matters periodically;

#### **18. DECIDES** as follows:

- i) non-implementation of audit decisions will be sanctioned and those concerned will be held accountable;
- ii) all concerned Departments/Directors/Offices of the Commission will henceforth attend meetings where audit matters are being considered with a view to ensure implementation of recommendations;
- the Commission should ensure that it carries out most of its activities hence scale up the execution rate of available funds in the first half of the year, in order to achieve a satisfactory implementation rate by the end of each financial year;
- iv) the Commission should propose realistic project implementation plans based on the available funds and human resources capacity. In this regard, the Commission should carry out an audit of human resources capacity and staff performance;
- v) in preparing reports on budget performance, the Commission should include detailed information on the funds received showing the breakdown of the monies received from each Partner;
- vi) over-expenditure of budget allocation without authorization, will be addressed in line with the existing rules and in particular the Financial Regulations and Rules;
- vii) the Commission should set deadlines for internal and external audits, and take necessary measures to ensure that those deadlines are met;
- viii) the Office of Internal Audit should undertake an audit of the reserve funds of the Union and present the report during the first quarter of 2016 to the Executive Council in July 2016, through the PRC;
- ix) the PRC should meet quarterly to follow-up on the implementation of audit reports and decisions.

#### E. ON MULTILATERAL COOPERATION - Doc. EX.CL/928(XXVIII)v

a) On the Evaluation of the Africa's Strategic Partnerships

#### 19. REQUESTS:

- the PRC through its Sub-Committee on Multilateral Cooperation in collaboration with the Commission to continue its evaluation of Strategic Partnerships and to submit its recommendations in the envisaged overall evaluation report during the June 2016 Summit;
- ii) the Commission in collaboration with the PRC to engage the Partners and other relevant stakeholders, with a view to identifying areas of competencies of the Strategic Partners.
- **20. CALLS ON** the Commission to align the African Union Program Budget, jointly funded by Strategic Partners, according to the priority areas identified in the First Ten Year Implementation Plan;
- **21. DECIDES** that the African Ambassadors accredited to the African Union take the lead in representing Africa before the Partners, while soliciting the views of their respective Ambassadors accredited to the Partner;
  - b) On Rescheduling of Partnerships Summits
- **22. ENCOURAGES** Partners or designated host countries to ensure that other Partnership Summits' meetings (Senior Officials and Ministerial Meetings) are held in the same venue and immediately precede respective Partnership Summits where feasible:
- 23. APPROVES a five year cycle and organize two partnership meetings per year as from 2017 for all Strategic Partnerships and CALLS ON the Commission to adopt its gradual implementation taking into consideration the need to reschedule previously adopted Partnership meetings accordingly, including at the Summit level, and in consultation with the respective Partners and host countries;
  - c) On Involvement of the Sub-Committee at meetings with Partners

#### **24. REQUESTS** the Commission

- to ensure that financial provisions are earmarked to cover the cost of participation of the representatives of the PRC and the Sub-Committee on Multilateral Cooperation in all partnership meetings abroad, while ensuring holding such meetings at the Headquarters of the African Union whenever possible;
- ii) to review the Banjul Formula;

#### d) On Africa-Arab Partnership

- **25. REQUESTS** the Commission in collaboration with the League of Arab States to finalize consultations on Paragraph 27 of the Concept Note with regard to the invitations to be addressed to AU Member States and continue preparations for the Summit as per the agreed roadmap;
  - e) On Africa-India Partnership
- **26. REQUESTS** the Commission in collaboration with the PRC to follow up on the implementation of the Declaration and Framework for Strategic Partnership adopted by the 3<sup>rd</sup> Africa-India Summit;
  - f) On Tokyo International Conference on African Development (TICAD)
- **27. COMMENDS** the Islamic Republic of the Gambia and Kenya for the agreement reached to hold the TICAD VI Summit in Nairobi, Kenya;

#### 28. ENDORSES:

- i) the agreement to hold TICAD VI Summit in Nairobi, Kenya, on 27-28 August 2016;
- ii) the proposal by the Co-organizers to combine the holding of the Second TICAD V Ministerial Follow-Up and of the TICAD VI Ministerial Preparatory Meetings.
- **29. APPROVES** the offer made by:
  - i) The Islamic Republic of the Gambia to host the combined Ministerial Meeting and **REQUESTS** the Commission, in close collaboration with host and Co-Organizers of TICAD, to propose a suitable date for the said Ministerial meeting, and to engage in active preparations;
  - ii) Djibouti to host the Senior Officials Meeting for the combined Ministerial Meeting in March 2016.
  - g) Forum on China-Africa Cooperation (FOCAC)
- **30. REQUESTS** the Commission in collaboration with the PRC to follow up on the implementation of the outcomes of the Johannesburg Summit Plan of Action and to develop a follow-up mechanism in that regard;

#### h) On Africa-Korea Forum

#### 31. REQUESTS:

- i) the Commission in close collaboration with Ethiopia ,the host country and Korea, to propose, for consideration by the PRC, a new suitable date for holding of the 4th Africa-Korea Forum in 2016;
- ii) the Commission in collaboration with the PRC, together with Korea, to take the necessary steps to ensure effective preparation for the 4th Africa-Korea Forum and to speed up the process of consideration of the draft working documents to be communicated to Member States;
- i) On Africa-South America Cooperation Forum (ASA)
- **32. ENCOURAGES** all Member States to participate in the 4<sup>th</sup> Africa-South America Summit to be held in Quito, Ecuador, 5-7 May 2016;
- **33. REQUESTS** the Commission, together with the South American side, to take the necessary steps to ensure effective preparations of the 4<sup>th</sup> ASA Summit and the Commission to start preparations for the Summit in collaboration with the Sub-Committee on Multilateral Cooperation to speed up the process of consideration of the draft working documents;
  - j) On Africa-EU Partnership

#### 34. REQUESTS

- i) the Commission in collaboration with the PRC and the European Union side to agree on a date for the Joint Africa-EU Joint Annual Forum (JAF);
- ii) the Commission in collaboration with the PRC to take the necessary steps to ensure effective preparation of the JAF and to speed up the process of consideration of the draft working documents.
- k) Africa-Turkey Partnership
- **35. REQUESTS** the Commission in collaboration with the PRC to engage in consultations with Turkey regarding a more suitable date for the 2<sup>nd</sup> Senior Officials Meeting;
  - I) On the Recruitment of staff for the Partnership Management and Coordination Division
- **36. CALLS UPON** the Commission to fast-track the recruitment of staff to fill the approved and VACANT positions within the Partnerships Division, to enable the

Division undertake its numerous and challenging mandate, and report back to the next session of the Executive Council in June 2016;

## F. ON REFUGEES, RETURNEES AND INTERNALLY DISPLACED PERSONS IN AFRICA – Doc. EX.CL/928(XXVIII)vi

- 37. **RECALLS** the decision EX.CL/Dec.567(XVII)of the Executive Council to increase the assessed contribution of Member States for assistance towards alleviating humanitarian situation from two (2) % to (4) %, to request the appropriate policy organ to implement this decision, in view of the increasing complexity of humanitarian situations on the continent;
- **38. REQUESTS** the Commission and Member States to assist the PRC to organize and carry out assessment missions to the countries affected by dire humanitarian situation by relaying information on requests to carry out assessment missions to respective capitals in good time;
- **39. ALSO REQUESTS** the regional Deans to nominate heads of delegations in time to ensure that assessment missions are carried out as scheduled:
- **40. FURTHER REQUESTS** the Commission to ensure that appropriate follow up action on assessment missions is undertaken by engaging national stakeholders, civil society organisations and international partners;
- 41. CALLS UPON the African Union to speak with one voice at the World Humanitarian Summit (WHS) scheduled for Istanbul, Turkey, in 2016 and ALSO CALL UPON Member States and the Commission to implement the recommendations in the Common African Position (CAP);
- **42. REQUESTS** the Commission to report on the implementation of this decision in January 2017;

#### G. ON CONTRIBUTIONS

- **43. WELCOMES** the efforts by Member States to pay up their contributions and Urges those Member States that have not yet done so to honour fully their obligations;
- **44. FURTHER WELCOMES** the support of development partners to the organization and **CALLS ON** them to honour their commitments;
- **45. DECIDES** on the temporary exemption of State of Libya until the beginning of the 2017 financial year, taking into account its commendable and generous contribution to the Union in previous years and the difficulties it has been facing for the last few years; and **EXPRESSES** its solidarity with the People and the Government of the State of Libya to whom Council wishes a quick recovery;

- **46. REQUESTS** the Commission to hold discussions with Member States that are in arrears with a view to coming up with a payment plan/schedule;
- **47. CALLS UPON** Member States that are in arrears of over two (2) years to settle the arrears promptly, to avoid sanctions being applied on them in accordance with the existing rules;
- **48. FURTHER CALLS UPON** the United States of America to lift the long- standing unilateral economic sanctions imposed on The Sudan, to allow the latter to meet its commitments to the African Union and other International Organizations;
- **49. REQUESTS** the Commission to explore means of opening an account within Africa dedicated to and aimed at facilitating timely payment of contributions by Member States:
- **50. APPROVES** the setting up of a Committee of the PRC to oversee the implementation of the sanction regime and to study the issues relating to the banks and the currency used by the organization in light of the new challenges faced in the global arena;
- **51. WELCOMES** the efforts by the Ad-hoc Ministerial Committee on the Scale of Assessment which has met on the margins of the 28<sup>th</sup> Ordinary Session of the Executive Council in January 2016 and finalized consultations with and reached final conclusion on the proposed new scale assessment of the Republic of Angola;
- **52. DECIDES** to maintain sanctions on the **Central African Republic** for non-payment of its assessed contributions and accumulated arrears since the 2011 financial year;
- **53. ALSO DECIDES** to impose sanctions on the following:
  - **Republic Sao Tome and Principe** for non-payment of its arrears of contribution for the last two (2) financial years;
  - Republic of Somalia for non-payment of its contributions since the 2010 financial year and not honouring the request to pay up at least fifty percent (50%) of its arrears before the end of the 2015 financial year.
- **54. FURTHER DECIDES** to maintain the temporary exemption granted to the Republic of Madagascar as long as it continues to honour its obligations in line with the agreed plan.

#### H. ON ECONOMIC AND TRADE MATTERS

**55. REQUESTS** the Commission to conduct a continent-wide study to investigate the causes of shortcomings in the African Growth and Opportunity Act (AGOA)

- process and make the most of the experiences of countries that have recorded better economic and commercial performance in this process;
- **56. ALSO REQUESTS** the Commission to remain engaged with the United States to ensure that there is no erosion of preferences available to Member States under AGOA;
- **57. URGES** Member States to set up their national AGOA response strategies to take better advantage of the economic and commercial potential of AGOA;
- **58. ALSO URGES** Member States to define a common African position and respect the commitments that will be made in this context to ensure that the Africa speaks with one voice on this matter at major international meetings on negotiations of trade agreements;
- **59. FURTHER URGES** Member States to speed up the implementation of the Continental Free Trade Area (CFTA) process by allocating the funds necessary for the indigenization of the negotiation process to allow the Commission to train more national experts and those within the Permanent Missions of Member States in Addis Ababa, Ethiopia;
- **60. CALLS ON** Member States to sign and ratify expeditiously, the Protocols establishing the Pan-African financial institutions, ACB, AIB and AMF, with a view to providing the continent with adequate resources for the implementation of the Continental Development Agenda [full name of Protocols];
- 61. URGES Member States and negotiating regions to forward their signed Economic Partnerships Agreement (EPAs) to the Commission which in collaboration with the United Nations Economic Commission for Africa (UNECA) are mandated to analysing them and ensuring that they are compatible with Africa's development as framed in Agenda 2063;
- **62. ALSO URGES** Member States to expeditiously designate their Chief and alternate Negotiators as well as focal points within their respective Permanent Missions in Addis Ababa in preparation for the negotiations on CFTA that are about to start;
- **63. REQUESTS** the Commission to capitalize on the commitment of China within the Forum on China-Africa Cooperation (FOCAC) and the Memorandum of Understanding (MOU) signed with China for industrialization;
- **64. ALSO REQUESTS** the Commission to urgently organize a Ministerial Roundtable on current economic, financial, agricultural and humanitarian challenges facing the continent with a view to addressing these challenges and designing an African forward-looking response aimed to build long-term resilience;

- **65. FURTHER REQUESTS** the Commission in collaboration with Member States to fast-track the implementation of flagship programmes such as the Grand Inga Dam Project to unleash the economic potential of the continent;
- **66. REQUESTS** the Commission to report on the implementation of this decision to the July 2017 ordinary session of the Executive Council.
  - I. ON THE NEW PARTNERSHIP FOR AFRICA'S DEVELOPMENT (NEPAD)
- **67. RECOMMENDS** to the Assembly to:
  - i) Request the Commission to expedite the finalization of the integration of NEPAD Planning and Coordination Agency (NPCA) into the African Union (AU) structures and processes, particularly in light of the envisaged restructuring exercise of all the AU Organs, with a view to avoiding programmes overlap and duplication;
  - ii) Also Request the Commission, in collaboration with NPCA to propose well defined criteria for eligibility of Member States for NEPAD projects which should take into account all Member States;
  - Declare the vacancy of the position of the Chief Executive Officer (CEO) of NPCA and request the NPCA Secretariat in collaboration with the Commission to circulate the Terms of Reference of the position to all Member States;
  - iv) **Extend** NEPAD programmes and projects to the Sahrawi Arab Democratic Republic and Somalia;
  - v) **Decide** that the harmonization of medical products should take into account the draft AU model law on regulation of medical products;
  - vi) **Request** NPCA to provide clear completion time lines for the infrastructure development projects with respect to the sixteen (16) Mega projects as well as the new projects in the pipeline on the continent.
  - J. ON SPECIAL EMERGENCY FUND FOR DROUGHT AND FAMINE IN AFRICA
- **REQUESTS** the PRC to ensure harmonization between the objectives and mandate of its sub-Committees including with those relating to refugees due to the similarity of issues dealt with and in the interest of synergy, thereby avoiding duplication of efforts; and make necessary arrangements for the participation of the Members of SEAF on the humanitarian assessment missions of the Commission;

- **69. REQUESTS** the Commission to sensitize Member States, on the status of the Fund and the need to replenish it without delay in order to combat the dire humanitarian situation on the continent:
- **70. ALSO REQUESTS** the PRC in collaboration with the Commission to develop a timetable for the organization of the Donors' Conference aimed at mobilizing additional resources to ensure sustainability of the Fund, to enable address among others, the effects of the El Niño phenomenon;
- **71. FURTHER REQUESTS** the Commission to take all necessary steps, in collaboration with the competent organs, to harmonize all offers made at different foras (COP21 and G8) in order to maximize the use of possible funds released;
- **72. REQUESTS** the Commission to continue to raise awareness in 2016 on the effects of climate change in Africa, particularly on the impact of El Niño in East Africa, Southern Africa and other regions of the continent;
- 73. CALLS UPON Member States to pull their risks together in the area of climate change by joining the African Risk Capacity (ARC);

African Union Staff Regulations and Rules and submit same to the Host Government for its consideration;

viii) The Host Government to borrow a leaf from other countries which host International Organisations with respect to the modalities those countries use to implement the diplomatic privileges and immunities.

This policy, which is regularly accompanied by the closure of access to the old town, in violation of the right to free movement of Palestinians within the occupied territories, is part of a deliberate willingness to judaize Al-Aqsa, the third holiest site of Islam, through division in space and time, and change the names of the main Christian-Muslim religious and worship monuments as well as historical places of Al-Aqsa to Hebrew names;
  - vi) The African Union to denounce excessive and disproportionate use of force by Israel against the peaceful resistance of the Palestinian people including, in some cases, by using unconventional means. Such practices are comparable to war crimes under international law;

    - b) its previous decisions adopted on ICC;
    - c) its previous decisions on the deferral of the proceedings initiated by the ICC against the President of the Sudan and the Deputy President of Kenya in accordance with Article 16 of the Rome Statute which allows the UNSC to defer cases for one year;
  - ii) COMMEND the Republic of South Africa for complying with the Decisions of the Assembly on non-cooperation with the arrest and surrender of the President of the Sudan and decide that by receiving President Bashir, the Republic of South Africa was implementing various AU Assembly Decisions on the warrants of arrest issued by the ICC against President Bashir and is consistent with its obligations under international law;
  - **REITERATE** its decision on the need for all Member States to comply with the Assembly Decisions on the warrants of arrest issued by the ICC against President Bashir of The Sudan pursuant to Article 23 (2) of the Constitutive Act and Article 98 of the Rome Statute of the ICC:
  - **EXPRESSES ITS DEEP CONCERN** regarding the wisdom of the continued prosecution of the case of Deputy President William Ruto of the Republic of Kenya and to **CALL ON** the ICC to terminate the case without further delay as any continued prosecution is without foundation given the unambiguous absence of any incriminatory evidence capable of belief;
  - v) COMMEND the members of the Open ended Committee of Foreign Ministers ("Open ended Ministerial Committee") under the chairpersonship of H.E. H.E. DR. Tedros Adhanom Ghebreyesus, Minister of Foreign Affairs of the Federal Democratic Republic of Ethiopia for the work done and to

**REITERATE** its previous decision that the Open Ended Ministerial Committee meet with the United Nations Security Council in order to engage on all issues that have been consistently raised by the African Union;

- the ICC in which the ASP reaffirmed its understanding on the non-retroactive application of Rule 68 to situations commenced before November 2013 (with regard to the Kenyan agenda) and expressed "willingness to consider, within the framework of the appropriate subsidiary body of the Assembly, proposals to develop procedures for the implementation of Article 97" (with regard to the South African agenda) and to EXPRESSES ITS APPRECIATION to the President of the Assembly of States Parties, H.E. Sidiki Kaba for ensuring that in spite of perceived resistance by some State Parties, the issues and concerns of the African Union and its member states were allowed to be articulated at the 14<sup>th</sup> Assembly of States Parties to the ICC;
  - deeply aggrieved by the failure of the UN Security Council to respond to the requests of the AU for deferral of the Sudan and Kenyan cases for the past five years;
  - b) **taking serious issue** with the capture of the ICC by the so-called "Principles of the Court" comprising the Prosecutor Registrar and President of the Court in the continued privileging of views of civil society over clearly held positions of African Member States parties to the Rome Statute:
  - c) Noting the disturbing public dismissive disregard of the decisions of the 14<sup>th</sup> ASP by the Prosecution in relation to the pending Rule 68 Appeal against Kenya's Deputy President.

#### vii) **DECIDE** that:

- a) the Bureau of the Open ended Ministerial Committee be expanded to ensure equitable regional representation AND REQUESTS the Overall Dean and the Regional Deans in Addis Ababa to urgently undertake consultations with a view submitting their respective representatives to serve on the Bureau;
- b) the Permanent Representatives' Committee approve adequate resources to the Commission through the Office of the Legal Counsel to support the work of the Open ended Ministerial Committee in pursuing all political, legal, and strategic avenues in addressing AU's concerns before the United Nations and the ICC;
- c) the Open-ended Ministerial Committee review the ICC's interpretation of its power pursuant to Article 93 of the Rome Statute

to oblige State Parties to forcibly compel unwilling witnesses to testify before the Court, in order to reject witness compulsion *in toto* and inform the Court and the next ASP accordingly;

- d) the Open-ended Ministerial Committee's mandate include the urgent development of a comprehensive strategy including collective withdrawal from the Court to inform the next action of AU Member States to the Rome Statute, and to further submit such strategy to an extraordinary session of the Executive Council which now has mandate to take such decision;
- e) the Peace and Security Council consider the draft ICC Action Plan on Arrest Strategies that is currently under consideration that by organization in order to make recommendations to the next AU Summit in June/July 2016 on a common African position;
- the Commission continues to engage with relevant stakeholders within the ICC in order to issues raised in the various Decisions of the AU Policy Organs on the ICC;
- g) the AU Mission in Brussels provide secretariat and institutional support to the African Group in The Hague in order to ensure effective coordination of its activities.

#### viii) REITERATE:

- the imperative need for all African States Parties to the Rome Statute of the ICC to continue to ensure that they adhere and articulate commonly agreed positions in line with their obligations under the constitutive Act of the African Union;

  - v) Shall receive relevant information from the Commission on the status of contributions;
  - vi) The Sub-Committee on General Supervision and Coordination on Budgetary, Financial and Administrative matters reports and makes recommendations to the AU Policy bodies through the PRC.

- **6. FURTHER DECIDES** to create a Sub-Committee on Budgetary Matters which will:
  - be specifically responsible for the Technical evaluation of the AU draft budget;
  - ii) monitor the efficient utilization of financial resources and budget implementation, the Union's annual budget be segmented in four quarters;
  - iii) reinforce the technical evaluation of the draft budget, Member States be encouraged to enlist the assistance of experts from their national Ministries of Finance, to participate in the deliberations of the Sub-Committee;
  - iv) The Membership of this Sub-Committee will be open-ended.
- **7. DECIDES** to restructure the Ad-hoc Ministerial Committee on Scale of Assessment as follows:
  - i) Becomes a full-fledged Ministerial Sub-Committee on Scale of Assessment;
  - ii) For the purposes of streamlining and enforcing the collection of contributions, the Ministerial Sub-Committee on Scale of Assessment takes over the tasks of the Sub-Committee on Contributions;
  - iii) The Ad-hoc Ministerial Sub-Committee should therefore, be reformed and renamed as the Ministerial Sub-Committee on Scale of Assessment and Contributions.
- **8. DECIDES** that, to ensure accountability and transparency, the Board of External Auditors, shall:
  - Submit its reports simultaneously to the AUC Chairperson and the PRC Chairperson through the Chair of the Sub-Committee on General Supervision and Coordination on Budgetary, Finance and Administrative matters;
  - ii) Submit an Interim report before the June/July Summit every year;
  - iii) Present its reports directly to the Sub-Committee on General Supervision and Coordination on Budgetary, Financial and Administrative Matters every six months:
  - iv) Be re-constituted and henceforth be composed of 5 nominated members (one per region) plus the members of the first tier.
- **9. DECIDES** that the Ad-hoc Ministerial Committee on the Scale of Assessment shall remain seized of the matter with a view to:

- Revising and aligning the mandates of other relevant Sub-Committees and mechanisms;
- ii) Clarifying the interaction between all the relevant Sub-Committees and mechanisms affected by the proposed re-structuring in implementing Assembly Decisions 561(XXIV) and 578(XXV).
- 10. REQUESTS the Commission, particularly the Office of Legal Counsel, to provide all the necessary support to ensure the implementation of the above recommendations. FURTHER REQUESTS the Commission to assist the Permanent Representatives of the Ad-hoc Ministerial Committee on Scale of Assessment in the review of the Terms of Reference of the relevant Sub-Committees and mechanisms affected by the proposed re-structuring in implementing Assembly Decisions 561(XXIV) and 578(XXV);

- iii) An agreement to work with partners with respect to providing resources to mitigate disasters.

- To request the Islamic Republic of the Gambia to carry out consultations. In the meantime, the AU would reflect on the practical modalities of convening such a world conference;
